- Question:** Players' registration in KSCA app is having a problem – showing red sign against player of a team which does not allow scorer to accept for nomination. This is impacting Umpires to go ahead in starting the game.

Reply: Scorer to coordinate with KSCA officials to eventually resolve the issue before umpires proceed in conducting the game with minimum time delay.

Also, KSCA appointed scorer to verify data prior to scheduled game within time to avoid delay & inconvenience in commencing the match.

- Question:** Attire by players of teams to be as per KSCA Playing conditions.

Reply: Umpires to use their diligence in handling this effectively & efficiently. To ensure that all players comply with KSCA PC by informing teams well in advance.

3. **Question:** Delay in call & signal of NOBALL by strikers end Umpire - field restrictions during limited overs game

Reply: Umpires to handle as per PC protocol judiciously with high Presence of mind. If, not called in time, if after realizing there is an error, umpires to call & signal NOBALL before the start of next delivery to be followed by subsequent actions as per Laws of Cricket.
