## Editorial

### Dr. B. K. Sadashiva A Fond Memory

The sudden and sad demise of Dr. B.K.Sadashiva has left a void in the umpiring fraternity. He was well – learned, bold, humane disciplinarian and



dedicated personality. A rare all round individual – so to say.

Sadashiva, called affectionately as B K S/DOC, created a rare image of his own in Cricket and Academic fields. Through his enormous contribution he won laurels — which are very difficult in both fields. A researcher par excellence, he gave a new dimension to some theories in the field of Organic Chemistry. His research paper won him an award by a University in France. He was well respected by the scientific community. I could say this because of the interactions and periodical discussions that were going on in Raman Research Institute (R R I) and Indian Institute of Science, which I was able to listen to.

Reverting to cricket, he was bold, knowledgeable and a strict disciplinarian as an umpire. He won the respect of players and officials alike by his way of handling the game with absolute control. He could handle any situation with ease, perhaps because of his experience as a first rate cricketer, leading the University and playing with some senior cricketers of the State. In a sense, he was a player-umpire too. His umpiring career started late, but gathered momentum to reach high levels due to his sincere efforts, discipline and dedication. It was rather unfortunate that he missed to reach the highest level (Test Cricket) due to lack of advice at the right moment.

B K S served the ACUK in all the important positions and his contributions were enormous. His dedication to duty and the manner in which he carried out his responsibilities was in no small measure for the smooth progress of the ACUK, over the years. His sense of dedication to duty is worth recalling. On the occasion of the Silver Jubilee of ACUK in 1999, a Souvenir was to be released by the then BCCI Secretary, Sri. J Y.Lele. The previous evening of the function, it was supposed to be ready. But in spite of sincere efforts by me as President, it was not possible to get it ready due to a sudden power failure. Moments of real tension. The press man told that he would get it ready by 6.30 a.m. the next day. I requested B K S, who was

the Secretary to go to the press and get the souvenir before time. When I rang up B K S at his house, I was told he had already left and was in the press, as early as 5.50 a.m. What a rare quality of dedication – remarkable. Later on, as President of ACUK, he won the appreciation and respect of one and all, for the forthright manner in which he conducted meetings.

Dr. B.K.S rendered valuable service to KSCA in many capacities including an important portfolio as In Charge of the Match Referees. His work was well appreciated and acknowledged by the Referees who were former International Cricketers. B K S also officiated as Umpires' Coach of the BCCI. His reports were sincere, down to earth and he left no room for indiscipline among umpires. I had the opportunity of listening to him during our periodical meetings of BCCI. He was concerned about the declining standards of umpiring in spite of very good facilities provided by BCCI. This was during our discussions while travelling and while we shared rooms in hotels. He was very firm that an umpire cannot commit even 1-2 % of mistakes which change course of a match. He was of the opinion that with BCCI taking good care of umpires—even at the International level, the talent is there.

I can only conclude that such an all-round and rare personality has disappeared and the umpiring fraternity is poorer, all the same.

### Answers For Quiz of Volume 194

As per KSCA playing conditions

- 1. The closing time of play is 05:20 p.m. 20 mins of playing time is lost in the process of correcting the scores which is added to the original time for close of play.
- 2. Team B has won on better run rate.

Team A = 265 for 8 in 50 overs. Run rate = 265/50 = 5.300

Team B = 107 for 4 in 20.1 overs. Run rate =  $107/121 \times 6 = 5.305$ 

- 3. It is for either or both umpires to call and signal Dead ball as they are satisfied about the difficulty in recovering the ball. More so, a fielder has expressed the same. Hence the completed 3 runs shall be allowed on call of dead ball. Totally 1 wide & 3 completed runs(4runs) are allowed.
- 4. The result of the match is a tie. As wickets lost are also equal the qualification of the team shall be decided by 'Spin of Coin" in the presence of the umpires
- 5. The Bowler's end Umpire shall call and signal No-ball and when the ball is dead, repeat the signal and tap his head with the other hand to the scorers. Further he shall caution the bowler, inform the other umpire, the captain of the fielding side and the batsmen at the wicket of what has occurred. This caution shall apply throughout the innings, even though the bowler may later on change ends.

### Answers as per MCC Laws:

- Captain/Deputy/Manager/Coach/ or any other person connected with the team can nominate the players before the toss. Only a nominated player can act as a deputy after the nomination and for the toss.
- 2. Yes, provided both the captains and umpires agree to do so in the interest of saving time.
- 3. Fielding the ball:
  - a) Occurs only when the ball is in play.
  - b) Occurs only within the field of play.
  - c) Only fielder/s can field the ball.
  - d) Possibility of either batsman getting dismissed exists.

### Retrieving the ball:

- a) Occurs only when the ball is dead.
- b) Occurs generally outside the field of play and exceptionally inside the field of play.
- c) Any fielder/s or any other person can retrieve the ball.
- d) Neither batsman can be dismissed.
- 4. As soon as the ball hits the protective helmet of the fielding side kept behind the wicket keeper, the ball is dead or either umpire shall call and

signal dead ball for information of the players. Since the second run is deliberately short, no runs are to be allowed. Further the Bowler's end umpire shall inform the other umpire accordingly and return the batsmen to their original ends.

Further he shall award 5 penalty runs to the fielding side, inform both the captains as soon as practicable of the reason for the action. Finally the umpires together shall report the occurrence to the executive of the batting side and to any governing body responsible for the match.

5. Last hour = 4 to 5 p.m. (minimum 20 overs to be bowled)

Innings ends = 03:55 p.m.

Interruption = 04:18 p.m.

Overs bowled = 3.1

Resumption of play=04:35 p.m.

Number of overs to be bowled in the

last hour =?

Innings starts = 04:05 p.m.

Hence minimum overs to be bowled in the last hour = 20 - 1 = 19

Interruption at = 04:18 p.m.

Overs bowled = 3.1

Remaining overs to be bowled

= 19 - 3.1 = 15.5

Less overs lost due to interruption = 17 mins = 5

Therefore minimum overs on resumption of play are 15.5-5=10.5, i.e. 5 balls of the unfinished over and a minimum of 10 overs or 05 p.m. whichever is later.
