#### 'NURTURING UMPIRES' HAS NO SUBSTITUTE.

(Contd.. From June 2006 issue.)

There are very many instances of complaints and jokes about Umpires. Just pause a minute. Think about what can be done. The enormous blunders committed by a few handful of Umpires are highlighted instead of treating them as inevitable aberrations. When the aberrations become too many, it is necessary to take notice and react promptly. How can Umpires be supported? Financially -Yes. But that may not result in quality Encouragement - Yes. improvement. Matches are posted for Umpires to stand in. A good number of matches do not produce good cricket. Good cricket and quality Umpiring are complimentary to one another. In this context, if I can make an observation please think whether Umpires enjoy confidence of management. Presently this is appallingly low. An Umpire is constantly under duress. In fact he is certain that in a face off with a player or a group of players or a team, the Umpire has to lose out in the discussion even when he is right. So many times Umpires are of the opinion that they are not given a fair deal by management anywhere. The

administrators can take a leading stride towards correcting this opinion/view. Management should display to all persons in general- players, teams, coaches, managers, secretaries and umpires in particular that Umpire and Umpires' decisions are respected and valued. Such a display of confidence in Umpires should be openly visible for all concerned. Any players' criticism of Umpires' decisions should be condemned loudly. Umpires also should gear themselves up properly and must be seen, as friendly and continuously updating personalities and players must be encouraged to pour out their disappointment on Umpires' shoulders.

Identify a few Umpires-young, fit and knowledgeable. Keep them in good humour now and then. Let it be seen that they are consulted regarding philosophies and attitudes of players and teams. These Umpires, when they err may be handled toughly, but with a healing touch. Let it be generally understood that management acknowledges Umpiring is a difficult and easily criticisable task and that when management does not tolerate fools, it

also moves forward with good Umpires. In a match an Umpire is an officer of the Association on duty. If players question his actions, management should put it down strongly and this 'put down' should be seen and observed generally. Whenever there altercations on field, Umpires are asked to make a report, which is not always possible. Many times, it is beneath dignity of an Umpire to make a report of behavior of players. A player, due to frustration may be determined to create an impossible situation and thereby seek importance that has eluded him. He may be on the lookout for cheap publicity. Hence when the Umpire reports such happenings, trust him and talk to the player. Extension of such trust goes a long way in making the life of an Umpire more pleasant.

Umpires don't complain heat of the day, strains of 6-8 hours of standing in the middle and demands on their concentration continuously updating. In view of these and many more, it is very necessary to expect that they are handled with kindness and care. An Umpire is an officer on duty of the governing body. He is the official on field symbol of the Association. His stand should be accepted and supported by association without fail. Decision-making, whatever be the level is a very difficult exercise. All cricket related people - players, legislators, journalists, and spectators enjoy a common pastime -joke about Umpires and the associated faults. Included in the list are their brethren as well. These jokes should not affect the performance of Umpires. Yes, but Umpires are also human and hence are subject to reacting when these jokes are malicious. It is of course known that only faults are highlighted whereas correct decisions even if contested some times are not worthy of mention. For Umpires it is a very unfair world. Umpires are continuously needled. One infact calls for a few special qualities to be Umpires. Among this list of qualities, quite high up would be the one related to fairness and firmness in judgments.
