THE THIRD WORLD COUNTRY UMPIRES

Its almost fifteen years since the tests and the ODIs came under the supervision from the third country umpires. This was thought to be creating a Zero error platform for cricketers. In the next few years, there should be no challenging umpires' decision. No acrimony at all as it was in short, a utopian world of cricket.

Well has it really been so? Let us see. A third umpire has since been introduced. Then a match referee to monitor a host of events with particular reference to behaviour of players vis-a vis umpires. In the early days only run-outs, hit-wickets, stumpings came in the domain of possible reference to the third umpire(TV Umpire). Later after a few funny things took plays on the field, the players insisted and the ICC yielded that references to the third umpire be not discretionary one from the field umpire only when in genuine doubt, but every time such an a event was demanded on the field. Gradually the demand on the third umpire increased with the addition of boundary decisions, disputed catches and the like. There came about a few incidents when catches were disputed even if not required. References went on

increasing with each day. It seemed great effort was being made to justify such use of technology (some would say misuse) instead of working towards better cricket

None with a sane mind could have thought that the third country umpires (neutral umpires suggested that they are not necessarily neutral) would be a global phenomenon in the interim. In fact, it took less than 10 years for this to be global. After the honeymoon was over it took much less than 10 years to start doubting if this was worth the effort. It has killed the aspirations of home bread umpires. Instead of enhancing their power of positive thinking, their ambition started diminishing. No wonder the quality of the umpiring also diminished. It became immaterial that the quality of cricket played also contributed to the diminishing quality of the umpires.

Demand for the third country umpires started with a touring umpire being called a cheat. Two decades down the line, with another touring captain is accused of cheating. Could this be the beginning of a new system of umpires — THE NEUTRAL PLANET UMPIRES perhaps !!

UMPIRES' DAY
