Reputations of individuals can, unfortunately, influence the outcome of a game. The game of Cricket is also subject to this phenomenon. For ex: there are batsmen who are known as walkers, and bowlers for genuine appealing. We have the opposite kinds as well. These reputations create perceptions in the air, and hang around the decision points, creating confusions and dilemmas in the minds of Umpires. If only the players with such reputation seek to support the game first before rooting for their teams! Ideally, and hopefully, they ought to trigger a 'role model' influence on the game, which goes beyond the mere win or loss of the game. They need to create more sportsmen and sportsmanship, than kick up ruckus debate.

He thrusted upon umpires to be thorough in Laws and playing conditions and that they should go through it before any match day. He also narrated some of the incidents during his Umpiring days.

#### Questions and Answers

1. On the second day of the match in the morning the pitch is rolled for 3 minutes. Thereafter it rains. When the game starts again, how much time should the rolling take? place?

Full 7 minutes.

- Later on when the game is decided to start at a certain time can the batting captain have the choice of not rolling. Yes his decision can be upheld.
- 3. One side of the wicket is bad while the other side is playable. Can the match be played on one side only after the captains agree?

Its always better not to play the game on one side since the Laws doesn't permit.

 One team comes late to the ground by 10 AM but according to the Umpires the ground is not fit for play to start on time. But since one team is on time can the match be awarded to the team on time. Since the ground conditions are bad, and it is impossible to start the game on time the umpires should wait till the ground becomes fit for play and then only can take further action.

- 5. A bowler, in his follow through, runs on the Protected Area and damages it. His foot lands outside the the Protected Area and marks are created due to his spiked Shoes. The Umpire at the bowler's end walks towards the Protected Area and taps his foot to rectify the marks caused by the bowler. Observing this the Captain of the Fielding team questions the Umpire "Why he is doing this"?
- a) Is the Umpire correct in removing the debris?
- b) Should the Umpires do this when ever they see debris on the Protected Area?

Ans: a) Yes b) The Umpires are allowed to do this any time.
