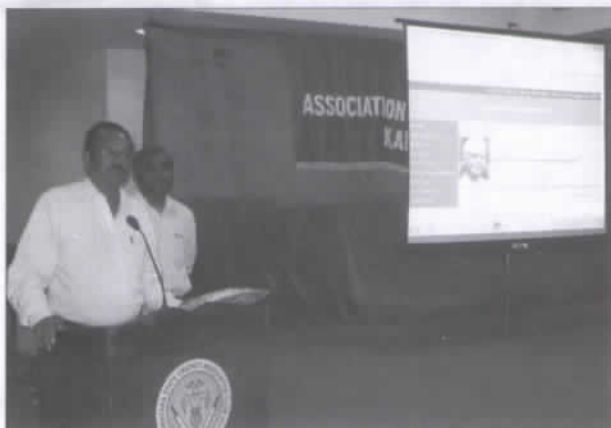

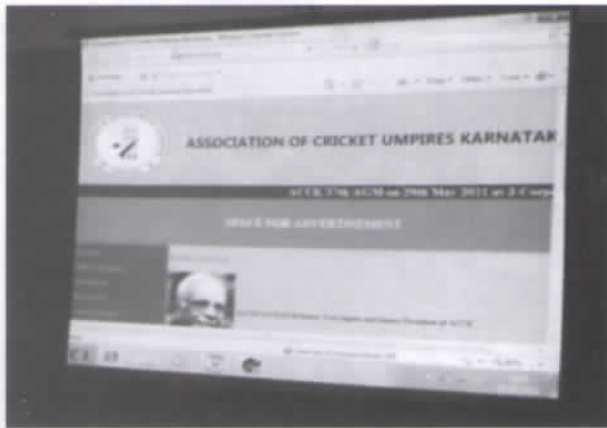

Ans. Batsmen is out caught because catch takes the precedence from other form of dismissal other than Bowled.

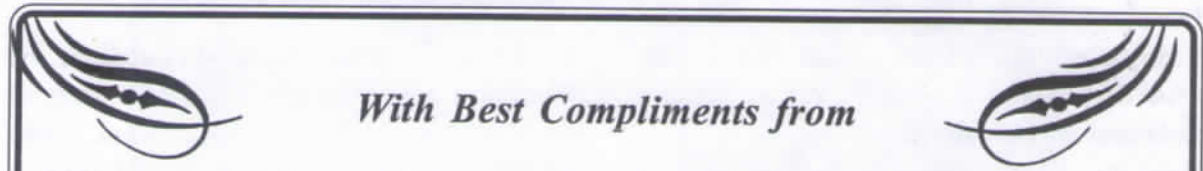
