#### **QUESTION & ANSWER**

**Q.** In a Group 2, 2<sup>nd</sup> division matches due to wet ground conditions the game was reduced to 15 overs a side. The team bowling first bowls only 14 overs in the stipulated time. The team bowling second has completed 13 overs in which the target has not been reached, and time has been called due to bad weather conditions. What should be the result of the match.?

**A.** Even though the game started with minimum of 15 overs since it has not been completed this matter has to be referred to KSCA technical committee to ratify the playing condition for the ensuing year.

**Q.A** ball lawfully struck twice hits the helmet kept behind the Wicket Keeper. Even though only runs scored after overthrow occurs, is 5 penalty runs given to the batting side?

**A. No.** Apart from the penalty of No ball if applicable no other runs are scored if overthrow does not occur.

## Questions collected from the MCC web site and International Institute of Cricket Umpiring & Scoring:

**Q.** The striker has a runner. The delivery is No Ball. The runner remains in his ground. The striker is out of his ground not attempting a run. Without the intervention of any other fielder, the wicket-keeper takes the ball, fairly removes the bails and appeals. What is the decision?

**A.** The Immunity for the stricker prevails for no ball. The stricker is not out.

Q. In a two innings match, a team falls short by 1 run in a thrilling run chase, losing their ninth wicket to a run out from the last ball with two runs needed to win. Its No11 was carried off the field after injuring his hamstring earlier in the day and he was not able to bat, even with a runner. What is the result?

**A.** Draw. Since the 11th batsmen is yet to play and not fit it is recorded as retired not out. Also the last ball of the match has already been bowled.
