MONTHLY MEETINGS

February 2013

Sri. Shahvir Tarapore narrated an incident which occurred in a school tournament for the benefit of umpires who may have to face such situations

The batsman who was supposed to come in at the fall of a wicket is delayed and did not enter the field at all. The umpires went in to enquire about the cause of delay and found that their coach is reluctant to send any batsmen in, for the reason that the match ball is not fit for play.

The first two questions in the Q and A column below pertain to this incident.

March 2013

The Secretary expressed displeasure regarding the yearly subscription which was due from a lot of members in spite of sending letters to them. He told the members not to feel bad when stern actions are initiated against those members who are in arrears for more than two years..

QUESTION AND ANSWERS

- Q. The question posed to the house was "when should the umpires rule the batsman out timed out"?
- A. The reason expressed by the batting side or its coach amounts to refusal to play. The match should have been awarded to the fielding side and the result recorded accordingly. Here it goes unsaid that the umpires shall jointly make a detailed report of the incident to the Secretary KSCA. However, if the batting side had a valid reason for the delay and had the game resumed, the incoming batsman shall be declared out timed out, once he steps on to the field of play.
- Q. How long can the umpires wait or try to convince the batting side to resume play?
- A. The umpires need not wait or try to convince any side to resume play. Infact, they shall order play to resume or invoke the law of refusal to play by a side.
- Q. Stumps provided in a match are not as per specifications. What is the action of the Umpires?
- A. All efforts should be made to acquire stumps of required specifications. The hosting authorities shall be responsible to provide the same.
- Q. Is there any difference between Player and Substitute?
- A. Player is one of the nominated eleven and a substitute can be anybody who will not be allowed to bowl, bat,act as wicket keeper or act as captain.
- Q. What is a difference between a player and fielder?
- A. A player is one of the nominated eleven and a fielder can be anybody who may or may not be one of the nominated eleven.

SIMPLICITY

A Ranji Trophy match of the Elite group was held at a centre in West Zone during a rainy season. The umpire on his pre-match routine visits the ground in

the wee hours of the morning and surprisingly finds a lot of police pickets at every corner of the ground. On entering the ground the umpire sees a lot of water pools on the ground and also a man in khakis, may be grounds man sponging water into a bucket. The umpire, who watches this act goes to him, strikes a conversation with him, and in an authoritive manner asks him how he alone will be able to clear the pool of water. Spat comes the reply, saab - after some time you will find lot of my fellow laborers working on this. The conversation ends here.

This umpire, since he is on duty takes a round of the ground and after some time is very surprised to see people enter the ground, go to this old groundsman and obtain his blessings, more so when a former Secretary of BCCI also, on arrival, goes to this man and obtains his blessings. Kindly imagine the state of mind of the umpire who talked to this grounds man in a very light manner. Well, the show has to go on. This umpire is given a local help who would assist him throughout his stay. Now, the umpire asks this local help as to who this old grounds man was and why there were a lot of police pickets which included the Superintendent of Police (an IPS officer). The reply puts the umpire totally off. This old man is the District Collector of the City (a very strict IAS officer with a lot of threats to his life) and also the President of the association, who every day is in direct contact with the Chief Minister.
