QUESTION AND ANSWERS

1) A throw from the deep is collected by the keeper with one of his gloves removed and still holding the same with the other hand. The ball touches the glove that is hanging in the hand. Does this act attract penalty?

- A) This question evoked a lot of debate amongst members. Finally it was ruled that, since there is no additional advantage to the keeper by removing the glove and holding it, he has not breached any law. As such there shall be no penalty.
- 2) Batsman plays at the ball and during the course the bat slips out of his hand and the ball comes in contact with the bat and crosses the boundary. Are any runs recorded, if yes how?
- A) Since the bat has slipped out of the batsman's hand, dead ball shall be called immediately and no runs shall be scored.
- 3) A fairly delivered ball without touching the bat touches the keeper's arm and then his helmet. The ball is then collected by the keeper and is thrown at the wickets since the batsman is outside the crease. Is the batsman out?
- A) Once the ball in play touches the keeper's helmet and then breaks the wicket without coming in contact with any other player, it is treated as directly of the fielder's helmet and the batsman shall not be given out.
