GLIMPSES OF SRI. S. N. HANUMANTHA RAO

Former Test Umpire and Former President of ACUK Sri. S. N. Hanumantha Rao has passed away and is not with us today. He was a devout umpire throughout his carrier and had never ever hurt the sentiments of fellow umpires. He could not share his expertise with the young upcoming umpires due to his waning health, but was ever ready to help anybody who approached him. We take this opportunity to remember this great personality through the minds of people who knew him very well

He passed away on the 29th of July 2013 and was 83 years of age. He stood in nine test matches and two one day internationals from 1978 to 1983. He

also went on to become a BCCI match referee. He is survived by his wife, three sons and a daughter.

As president of ACUK he contributed his might towards upholding the image of the umpires during an era where umpires where not much recognized as of now.

He became a glowing example of sportsmanship when in the Golden Jubilee Test Match between India and England at Bombay in the year 1979-80, he ruled Bob Taylor out, caught behind of the bowling of Kapil Dev. Taylor protested, but walked off. India's captain, Gundappa Viswanath, fielding at slip, was convinced that Taylor had not edged the ball, and persuaded Rao to overturn the decision. Rao agreed, and Taylor was called back. The result of the match didn't matter, but Rao's boldness to reverse his decision stood out.

Our immediate past president, Sri. Ravi Subramanyam remembers.

It is with great sorrow and a feeling of a big loss that I am writing about Sri S.N. Hanumantha Rao. He was one of the nicest and kind person I ever knew. I grew up watching and learning a lot of umpiring issues from him. He was respected a lot in the umpiring fraternity. He used to teach us a lot about umpiring, as to how we should be as an Umpire and also as a human being. He had a very great sense of humour and was always smiling and cracking jokes.

My relationship with him was a very personal one as I grew up in his house in Gandhi Bazaar in my childhood. My brother, late Sri Venu Subramanyam, alongwith Rao's children, Sri Prasad, Sri Bhanu, Sri Praveen and Smt Roopa played in the trees of his house during our childhood. He and my father were very close friends for a very long time. Both our families shared a very special relationship. He was always like a fatherly figure to me.

Along with him, Sri B Sathyaji Rao, Sri Vikram Raju, Sri B R K Murthy and my father Late Sri M G Subramanyam were all a great sense of inspiration to all of us in the field of umpiring and also my personal life.

I pray God to give his family the strength and courage to overcome this great loss as nothing can replace the loss of a person near and dear to everyone.

A Legend passes away – B.R.K Murthy – Former President - ACUK

The passing away of Mr.S.N.Hanumantha Rao recently has left a great void in the Umpiring Fraternity. My association with him dates back to my league umpiring in the early 60s. Un-doubtedly, he was a great inspiration to most of us and motivated us to take up to umpiring seriously and aim to make it to the BCCI panel. When we qualified for the panel in 73-74, he was the first to greet us and hosted a party to celebrate the same. It was also in the same year that Karnataka won their maiden Ranji Trophy and Mr.Rao was quick to suggest that we (a small group of 15 umpires) welcome the victorious team with a symbolic party. Our enthusiasm got a magnificient boost when the Doyen of Karnataka Cricket Mr.M.Chinnaswamy advised us that it would be more appropriate if we make a Forum of Umpires on this occasion. Thus came the birth of ACUK. The rest is history.

We can never forget those early days of ACUK. The entire requirements of stationary and meeting expenses were met by Mr. Rao. It is significant that he designed and presented the Association's first 'colour' to all Umpires and even KSCA officials. He along side, Mr.M.G Subramaniam, came up with a brilliant idea to organize 'Umpires Day' to commemorate the month when the great Mr.M.G Vijayasarathy, who was the first umpire to officiate in a Test Match. This event came about during my Presidency. We brought out a 'Souvenir' on this occasion and needless to say that these two gentlemen collected many advertisements and articles for the successful conducting of the Umpires Seminar.

It is suffice to say that Mr.Rao was a great inspiration and his dream has kept the flag of ACUK higher and higher. Besides all this, he was a great human being, very affectionate with his family and lived with them till his last breath. I will fail in my regards if I do not mention the untiring efforts of his wife and children to help him in all his efforts and made his life a model for many to cherish and follow.

Question and answers

1) On deliberate padding, one of the umpires call dead ball before the first run is completed, but the fielding team appeals for a run out after effecting one. What should be done on this situation?

The Umpire has erred in calling dead ball before the run is completed, but since the dead ball call has been made it shall stand and neither batsman shall be given out.

2) Bowler delivers a ball which is wide, but a fair delivery. What is to be done if before the ball reaches the batsman the close in fielder touches the ball?

Call dead ball and ball not be counted as one of the over.

3) A fairly delivered ball is driven by the batsman and without touching the ground hits the cap tucked behind the close in fielder and the same is caught by the fielder. Is the batsman out?

Yes, the striker is out caught as there is no willful act of the fielder.
