Monthly Meeting - April 2014

The President welcoming the gathering, briefed about the AGM to be held in May at a place outside Bangalore. He requested the members to come out with a place nearby to Bangalore, which would be suitable to conduct our AGM. He also announced that the league season would start from either 19th or 26th of April and requested all the members to be on time for the matches. He also expressed that the confirmation of availability of umpires, if not done within three days prior to the scheduled match day, the individual postings would be cancelled automatically.

Questions and Answers

- Q) If both the captains agree to forgo the tea interval, should the time for cessation of play, be brought forward on that day?

Members present expressed different opinions. The chair stated that a clarification on the same would be sought from the technical committee of the KSCA. For the time being, it was decided to stick to the stipulated duration of play in a day as mentioned in the playing conditions of the KSCA and thereby bring forward and re-schedule the time for cessation of play in proportion with the duration of the tea interval.
