Education:

Conflict situations and coping with them

- Conflict stems from pressure
- The handling of conflict situations requires special personnel management skills
- Poor handling of these conflict situations creates the basis for a difficult game and will place undue pressure on the umpires
- Animosity arises from two main sources;
 - Player versus Player
 - Player versus Umpire

• Player versus Player:

- Don't intervene too quickly
- Allow Players to have their say
- After a short time, defuse the situation with a suitable comment
- Some umpires have a dislike for getting involved whilst others step in too quickly
- Either of these paths can cause the loss of respect of the Players
- Approach Captains and ask them to take suitable action to control Players

Player versus Umpire:

- Stand by decision and reject guilt feelings
- Understand and recognise that you will not please everyone. At all times be consistent
- Never even up an error

- Show control and dispassionately explain your decision if asked
- Due to the nature of their decision making role, Umpires must expect that dissent may occur from time to time
- Each event which may lead to dissent should be assessed on its merit and dealt with appropriately (be consistent)
- Never lose your cool or else you will lose respect from everyone
- Never walk towards a Player in an aggressive manner or point a finger (body language)
- Any necessary reports must involve your Colleague/s, and the Captains should be informed at the earliest
- An umpire should be pleasant towards players, but always firm and exercise control in an unassuming manner
- An umpire should never ask a Player for his opinion on a decision. This attracts disrespect and a perception of lack of confidence
- An umpire must not talk too much. Nothing irritates the Players more than this
- Chattering affects concentration significantly (often that of the Umpire)
- Never call a Player for discussion, stand your ground and allow the Player to approach
- If you need to speak to a Player, wait until he comes close to you
- Knowing Players and Captains can influence attitude to be taken
- Let the players play the game
- Apply the laws with common sense
- Don't constantly lookout for minor technical violations to show off your knowledge of law
- Use laws as a deterrent; not a solution
- Know how to integrate laws
- Try to anticipate problems and solve them before they occur (read the game)
- Be Complimentary

- If Wicket-keeper replaces bails; say thank you!
- If you speak to a Captain about a Player's behaviour, finish the request with Please!
- After he speaks to a Player, say thank you!
- FINALLY use phrases like
 - Cool down
 - You had your say, now let us get on
 - Let's discuss later
 - You are there to facilitate good Cricket.

Information

Changes To ICC Playing Conditions Effective 5th July 2015

The main amendments to the playing conditions are:

ODI - Fielding Restrictions

No more compulsory catchers required in Overs 1-10. No more batting Power play. 5 fielders allowed outside the circle in overs 41-50.

ODI-Interval

If Team 2 is batting and a match is close to conclusion at the time the scheduled interval is reached, either captain can make a request to the umpires to extend play by an extra 15 minutes / minimum 4 overs to obtain a result.

Once the interval is taken, the referee has also been given discretion to reduce the interval time if he feels a result is imminent.

ODI & T20I-Free Hit from All No Ball

A Free Hit is to be awarded after all modes of No ball called. If the No ball was called for having too many fielders outside the circle, the field can be changed for the Free Hit even if there is no change in Striker, but only to the extent of correcting the breach.

Test, ODI & T20I - Significant movement by a Fielder or Wicketkeeper

The Law relating to defining significant movement of a fielder or a wicket keeper has been amended to allow movement before the batsman has played the ball, as long as it is in response to a movement by the Striker to play the ball.

Test, ODI & T20I - Attempting to run out the Non-Striker

The bowler is permitted, before releasing the ball and provided he has not completed his usual delivery swing, to deliberately attempt to run out the Non-Striker.

Test & ODI - DRS – Requesting a Player Review Change to Clause 3.2 of the DRS Playing Conditions

- a) Teams must request a Player Review within 15 seconds of the ball becoming dead, but one exception has now been added.
 - If the umpires use an Umpire Review to answer an appeal for a Caught decision, for either a fair catch or a bump ball, the request for a Player Review of that Caught decision may be made by either team within 15 seconds of the result of the Umpire Review being communicated.

Bapu Nadkarni, former Indian Cricketer achieved a rare feet in the Madras Test against England in 1963-64, his figures at the end of third day of the match was 32-27-5-0. At one time, it read, 29 Overs, 26 Maidens, and no Wickets for three Runs, bowling mostly against Brian Bolus and Ken Barrington.

In the process, he bowled a record twenty one consecutive maiden overs (131 dot balls in a row) in a 114 minute bowling spell.

"A match between Barbados and British Guyana in 1946 saw an over with 14 balls in which there were no Wide Balls or No Balls! The 8 ball over was in force and the extra six deliveries were due to umpire miscounting."
