in the elections held during the course of the AGM 2017, members bestowed the responsibility of managing the affairs of the Association in the hands of a new committee.



I would like to consider giving the ACUK Newsletter an identity, and it is in this direction that I am considering giving the Newsletter a name. I invite members to suggest possible names for the Newsletter; members may send suggestions to editorial.acuk@gmail.com.

I would like to touch upon four major subjects to begin with. First, I would like to express delight that the ICC had appointed four Women Umpires to officiate in the Women's World Cup 2017. While it doesn't have anything to do with the ACUK directly, it is a great initiative by the ICC to involve Women Umpires at the highest level of the game. Seen in the larger context, I am sure the four female Umpires will inspire a generation of Women Umpires, which will eventually result in the growth of the fraternity of Umpires. I call upon members, where possible, to encourage women cricketers (as well as all women interested in cricket) to take up Umpiring.



The ICC recently confirmed Afghanistan and Ireland as Full Members. Congratulations to the Afghanistan Cricket Board and Cricket Ireland for their newlyacquired status and good luck to them as they seek to take baby steps in Test cricket. What this elevation also means is that it will give Umpires in both nations a chance to officiate in higher level games. I am pleased for that opportunity being available to them.

The other important development was pertaining to the ICC Cricket Committee's recommendation that teams seeking DRS should not be penalized a 'Review' in case technology returned 'Umpire's Call'. On several occasions in the past, when technology has returned Umpire's Call, there have been opinions - from cricketers, commentators, journalists, and the ardent cricket fan – that Umpire's Call was introduced to safeguard the Umpires. If technology is reliable – to the extent that it is used as an official tool to assist decision making in sport - should it not be used to the fullest extent, without 'conditions apply'?

Should the ICC persist with 'Umpire's Call' anymore? I would request my fellow Umpires to share their thoughts on this subject; look forward to your responses at editorial.acuk@gmail.com. A few replies shall be reproduced in the next quarter's Newsletter.

My fourth topic for this edition of the Newsletter has to do with events that occurred in a T20 match in Edgbaston on July 8. The Nottingham Outlaws fast bowler Luke Fletcher, in his follow through, copped a fierce blow

on his head from a straight drive. Play was suspended immediately and the physio and on-ground paramedics attended to the player immediately. It was good to see the Match Officials take a humane approach to the situation; given how shaken the players were, they decided to suspend the match and allowed them time to gather their thoughts, and resumed the match about 30 minutes later. Though the player is now recovering, it has once again put under the spotlight if enough is being done to protect the players (particularly the

batsmen, the bowler and the close-in fielders) and the Umpires. What protective measures can Umpires take to avoid such injuries? What measures can be introduced to reduce such injuries to players and Umpires?

I hope you enjoy pondering about and discussing these topics with your colleagues. Look forward to hearing your thoughts on the same.

#### **AGM 2017**

The Annual General Meeting of the ACUK was held at the 'J' Corporate Hall in the KSCA premises on 26 June 2017. The AGM was an unprecedented success, with 210 members in attendance.

President Sri Vinayak Kulkarni chaired the AGM and proceedings commenced at 10:00 a.m. The members actively participated in the AGM; a few members sought clarifications to information provided in the AGM notice, a few others made suggestions for the betterment of the organisation.

The AGM proceeded as per the agenda printed in the AGM notice and members expressed their confidence by giving their approval to several items that needed the member's approval.

Item number 10 in the Agenda was 'Elections to the Working Committee for the term 2017 – 2019'. For this, the President sought the approval and the House consented to appoint Sri KL Subramanya as Returning Officer. #### **Record Breakers**

Indian cricketers have scaled many peaks in international cricket. Here's a brief look at some of the major records broken by Indian cricketers in the last few months.



• Jhulan Goswami became the highest wicket-taker in Women's ODIs. When she took 3-20 against South Africa in an ODI at Potchefstroom in May, Jhulan surpassed Australia's Cathryn Fitzpatrick to become the

highest wicket-taker in Women's ODIs.



• When Virat Kohli scored 111 not out in an ODI against the West Indies recently, he broke Sachin Tendulkar's record for the most centuries in ODI runchases; Tendulkar had scored 17 hundreds in ODI run-

chases, Kohli now has 18 hundreds in chases.



• When the Indian Women's cricket team captain Mithali Raj scored 69 in a World Cup match against Australia, she became the highest run-getter in Women's ODIs; in the same match, Mithali Raj also

became the first batter to score 6000 runs in Women's ODIs.

The ACUK congratulates the cricketers for their record-breaking accomplishments and wishes them plenty more success in the future.
