Umpires Day 2019

Cricket Law Quiz

Rules:

- The quiz is only open to members of ACUK
- Answers to be emailed in the order of questions mentioned to umpseetharam@gmail.com OR achiru88@gmail.com
- Entries to be received on or before 29th February 2020.
- First to send the correct answers will be eligible for the reward provided he/she is present at the monthly meeting where the reward will be distributed. If the person is not present at the monthly meeting the reward shall be passed on to the next person sending in the correct answer before the cutoff date
- ACUK working committee members, BCCI Umpires (present and retired) and non-members welcome to participate but shall not be eligible for the reward
- Questions are based on the latest MCC Laws of Cricket 2017 Code & KSCA Playing Conditions with subsequent amendments.
- Decision of the ACUK Editorial Committee shall be final and binding on all aspects.

Questions as per KSCA Playing Conditions

- 1. In playing condition 2, team A is all out at 01 p.m in 43.3 overs. How many runs penalty will the team bowling first attract?
- 2. In Playing condition 1, the start of lunch interval is extended by 30 minutes as 09 wickets are down. While the play is in progress, the captain of the fielding side approaches the umpire for an extension of 15 more minutes expecting a definite result. What should be umpire's decision?

- 3. In playing condition 2, team A scores 290 runs for 8 wickets in 50 overs at 12.30 p. m. There is a rain interruption from 02.30 p. m for 34 minutes. At that time, team B has scored 67/2 in 14 overs. Calculate the remaining overs and show the rescheduled timings.
- 4. In playing condition 01, what are the conditions for the last hour of the match to start?
- 5) What are the time limits for a player's unserved penalty time for playing conditions 1 to 4?

As per MCC laws

- 1) The striker after playing a no ball, along with his partner completes three runs and the non-striker having made good his ground, catches the ball thrown from the outfield and gives it to the bowler. An appeal is made. The umpire also warns the batsmen a second time for running on the pitch.
 - **a.** Is any batsman out? if so, who is out?
 - **b.** How many runs are allowed /scored?
- 2) A no ball lawfully struck twice is going towards third man. A fielder picks the ball and throws it back and the batsmen start running and complete one run. Meanwhile, the overthrown ball reaches the boundary. What are your actions?
- 3) What happens if time is reached and a mistake is found in the scores?
- 4) An appeal is not made prior to the call of over. Can it be made later? If so, when?
- 5) Are there any reasons in a multiday game, except on the final day, that time for close of play on any day be extended? If so, mention them.

Note: Answers should reach the Hon. Secretary or Hon. Jt. Secretary by e-mail on or before 29th of February 2020. Any other mode of answers or to any other mail i.d will NOT be considered.

Answers and winner will be announced during the monthly meeting of March 2020.

Monthly Meetings Q&A

- 01. In a multi-day game, 90 overs to be bowled for the day. In case, if not completed by scheduled or rescheduled cessation time for close of the play, what is the action?
- Ans. Play shall continue on that day until the completion of 90 overs or upto 30 mins beyond the scheduled or rescheduled cessation time (permitted over time).
- 02. When 9 wickets are down, a batsman is injured and is receiving medical attention. How long should the umpires wait?
- Ans. Whether 9 or any number of wickets are down, application remains the same. The umpires shall wait for a reasonable time and decide as per existing situation.
- 03. On a turf ground, there are some wet patches near one end of the square. What could be done to start the match on time?
- Ans. Mats, dry cut grass, sponges, etc. can be used to bring the wet areas to playable conditions.

Answers for Quiz of Volume 192 As per playing conditions

1. He can bowl after serving 40 minutes on the field of play on that day if play continues and/or on a subsequent day.

- 2. Hours of play: 10.12 a.m to 12 noon -1st session 12 noon to 12.40 p.m-Lunch 12.40 p.m to 3.10 p.m-2nd session. 03.30 p. m to 05.12 p.m-3rd session.
- 3. No re-scheduling, hours of play remain the same.
- 4. Having lunch in the interruption time of 45 mins and 10mins for change of innings, we get 49 overs for each side.

Timings: 09.30 a.m to 12.40 p. m – Team batting first. Revised Timings: 12.40p.m to 01.25 p.m-- Interruption(lunch) 01.25 p. m to 01.41 p.m -Team batting first (continuation) 01.41p.m to

- 01.51 p.m-Change of innings 01.51p.m to 05.17 p.m-Team batting second.
- 5. No.

As per MCC Laws:

- 1. Run is allowed as the ball is in play.
- 2. Neither overs is lost nor play is extended.
- 3. The striker is not out.
- 4. The match was actually concluded when the players left the field for the interruption and no further play was possible.
- 5. Yes.
